MARKET SUMMARY

The market closed the week with a turnover of UGX 13,582,007,020 and a total volume of 9,210,828 shares traded. The USE All Share Index closed the week at a 990.3 up from 975.25 the previous week. Total market capitalization closed at UGX 5,986.9 billion.

During the last session, BATU traded 220 shares at UGX 1,495 per share, NVL traded 7,800 shares at a new high of UGX 1,960 per share, SBU traded 1,632,856 shares at Ugx 255 per share, DFCU traded 217,250 shares at a high of UGX 805 per share, BOBU traded 1,750 shares at a high of 3025 per share and UCL normal counter traded 8,882 shares at Ugx 6,660 per share.

The Exchange witnessed the closing of the first ever Rights Issue trading of UCL which saw the rights price move between Ugx 3,500 and Ugx 4,015 per share. Outstanding bids and offers were registered on the SBU, UCL, NVL, DFCU and BATU counters.
