

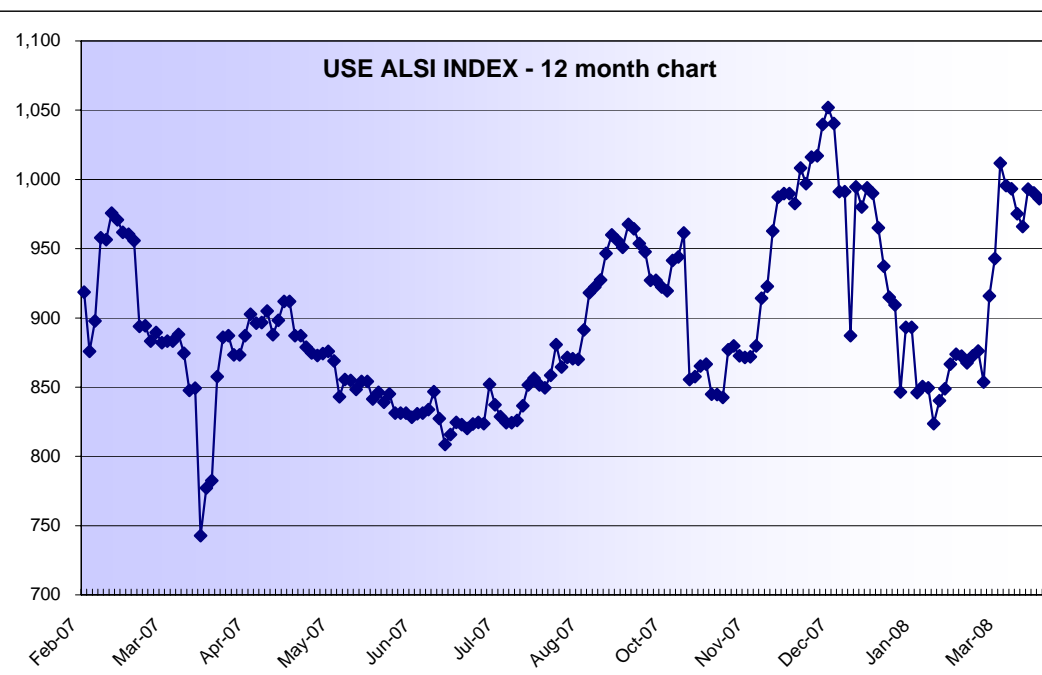

**MARKET SUMMARY**

The market closed the week with a turnover of UGX 743,832,525 and a total volume of 2,546,353 shares traded. The USE All Share Index closed the week at 985.98 down from 990.3 the previous week. Total market capitalization closed at UGX 5,960.8 billion.

During the last session, NVL traded 16,600 shares at a new high of UGX 2,020 per share, SBU traded 200,497 shares at Ugx 255 per share, DFCU traded 14,901 shares at UGX 800 per share, BOBU traded 1,900 shares at a high of 3085 per share and UCL normal counter traded 3,804 shares at Ugx 6,720 per share. Outstanding bids and offers were registered on the SBU, UCL, NVL, DFCU and BATU counters.

This Friday the regional market has witnessed the start of the Safaricom IPO which started today 28th March 2008 and will close on the 23 April 2008.
